



1. My overall assessment of the course







However, this worked nicely all in all. the use of miro is pretty good, especially for an online setting where it might be difficult to get someone to respond or speak up The teams worked well for the meetings. I think the online practicality worked fine. it was ok. But in person is always a million times better It was very well organized and good methods (Miro) were used for online teaching. But in the last week I noticed that I didn't get to know the fellow students from my course what is a pity. So, maybe it would have been nice to change more often the discussion groups and not only have the discussions with the case study group! But when possible I would prefer to have the guest lectures in the campus! I worked really good. I liked the group discussion and writing our findings in Miro and comparing them with the other groups. Through Miro I got a often a different perspective and new inputs. I would definetely keep Miro even if teaching is organised on campus and of course the Teams channel. Teams as streaming platform was good! Working in Miro was helpful (but it would be nice to have Miro link in more obvious place in Mycourses) Having the documents and "submitting" of them in Teams made things easier. Though it was a bit strange at start. It could be the way also in campus. Miro was also good method most of the time - in the end people started to feel quite tired of all short discussions. But that's how it always is :) Campus is of course more preferable:)
